- The candidates in the **General Waiting List** are advised to register their interest online for admission in case of any available vacancy (ies), **by or before 31st July, 2019** by submitting a waiting candidate's form available through the link <https://admission.iustlive.com/OnlineWaitingVerifyStudent.aspx>.
