GENERAL TERMS AND CONDITIONS/ INSTRUCTIONS.

1. The terms and conditions governing the service shall be as per the University Statutes with amendments from time to time.
2. The time taken by candidates to acquire M.Phil and /or Ph.D degree shall not be considered as teaching / research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment. The certificate to this effect issued by the Registrar of the Concerned University shall have to be attached by the candidate to claim for such experience.
3. Non NET/SLET/SET candidates applying for the posts of Assistant Professor are required to submit a certificate from the concerned University to the effect that the Ph.D degree obtained by him/her is in compliance with the UGC (Minimum standards and procedure for awards of M.Phil/Ph.D degree) Regulation 2009 as per prescribed format (Annexure A and AnnexureB). In case of failure to submit the said certificate and having not qualified NET/SLET/SET, they shall be declared ineligible for the post.
4. The candidates applying for the post of Assistant Professor who were enrolled for Ph.D. before July 11, 2009 will be governed by the 4th Amendment, UGC Regulations 2016, which is as under:
"Provided further, the award of degree to candidates registered for M.Phil/Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bylaws/Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-
(a) Ph.D. degree of the candidate awarded in regular mode only;
(b) Evaluation of the Ph.D. thesis by at least two external examiners;
(c) Open Ph.D. viva voce of the candidate had been conducted;
(d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in a refereed journal;
(e) Candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D. work.
The fulfillment of the above conditions are to be certified by the Dean (Academic Affairs)/Registrar.
5. Candidates who have been awarded post graduate/Ph.D degree from Foreign University should enclose Equivalence Certificate" issued by the Association of Indian Universities (AIU), New Delhi without which their candidature will not be considered and application form will be rejected.
6. Candidates are required to apply online through University website www.islamicuniversity.edu.in. No other means/ mode of application will be accepted. The processing fee (non-refundable) of Rs. 300/- (Rupees Three Hundred only) shall have to be deposited through online mode by debit card/ credit card/ net banking.
7. NET/SLET/SET shall not be required for such Master's Programmes in disciplines for which NET/SLET/SET is not conducted.
8. Hard copy of application form complete in all respects duly supported by attested copies of all relevant documents, certificates and testimonials is mandatory to be submitted in the office of Registrar by or before the last date of submission of hardcopies of the application forms, failing which the online application form submitted by the candidates shall not be considered. Applications received after the expiry of the due date will not be entertained.
9. Candidates (in addition to all publications) shall separately enclose & rate their best three publications for the post of Assistant Professor.
10. Eligible candidates will be informed about the date and place of interview through University website / e-mail/ whichever suitable. However, University does not take any responsibility for non receipt or delayed receipt of the intimation by a candidate.
11. Request from eligible candidates for conduct of interview through Skype or through any other live video shall not be considered. They shall have to appear in person before the Selection Committee as per the notified date, time and venue.
12. All relevant information /updates shall be uploaded on University website www.islamicuniversity.edu.in. The Candidates are advised to remain in touch with University website and notifying the same in newspapers shall not be obligatory on University part.
13. Candidates will have to produce original documents relating to their qualification, experience etc. at the time of appearing in the interview.

15. The University reserves the right to place reasonable limit on the total number of candidates to be called for interview for any post.
16. Candidates not fulfilling the requirements prescribed here-in-above as on the last date prescribed for submission of online application form need not to apply.
17. Experience if any shall be counted as on the date of the issue of the Notification.
18. The University shall verify the antecedents or documents submitted by a candidate at any time of the appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has undesirable/ clandestine antecedents and has suppressed any information, then his/her service shall be terminated.
19. Candidates who had applied earlier and sent their bio-data/academic vitae to the Vice-Chancellor or any other authority of the University must apply afresh online by following the prescribed procedure.

22. In case of any disputes /suits or legal proceedings against the University, the jurisdiction shall be confined to the court of Srinagar only.
23. The University reserves the right to modify/withdraw/cancel any communication made to the candidate(s) at any stage in the process of selection in case any inadvertent mistake is detected even after the issue of appointment letter.
24. No TA/DA shall be paid to candidates for appearing in the interview.
25. To assess the domain knowledge of candidates, the University shall conduct a Screening Test for shortlisting of candidates for interview. The Screening Test is likely to be held between 2nd to 3rd Week of July, 2019.
26. The Screening Test shall comprise of 100 Multiple Choice Questions (MCQs) having 01 marks each with time duration of 110 minutes. There shall be no negative marking in the test.
27. The candidates who would obtain a minimum of 45% marks in the Screening Test shall be considered for further shortlisting and the number of shortlisted candidates will be called for interview in the ratio of 1:5.
28. Shortlisted candidates will be intimated the exact date and venue for interview over email besides a separate list shall be displayed on the university website.
29. The final selection of shortlisted candidates will be made purely on the basis of the performance in the interview which shall comprise of 20 marks.
30. The selected candidates shall be engaged purely on temporary basis subject to his/her satisfactory performance in academic and administrative assignments given during the engagement period and does not constitute any employment with the University.
31. In case the performance is found unsatisfactory, the contractual engagement shall be discontinued immediately without giving any notice.
32. The selected candidates shall have to submit an Undertaking and an Affidavit as per the prescribed format each on Rs. 100/- stamp paper duly notarized.
33. The continuation of candidates' service for another year during the contractual period, shall depend on his/her annual performance appraisal by Concerned HoD/ Dean of the School and student feedback.
